

NETXINVESTOR REGISTRATION GUIDE

Below are step-by-step instructions for an investor with brokerage accounts held with Pershing, LLC. to be able to register and set up online access to their accounts as well as assist with setting up eDelivery preferences.

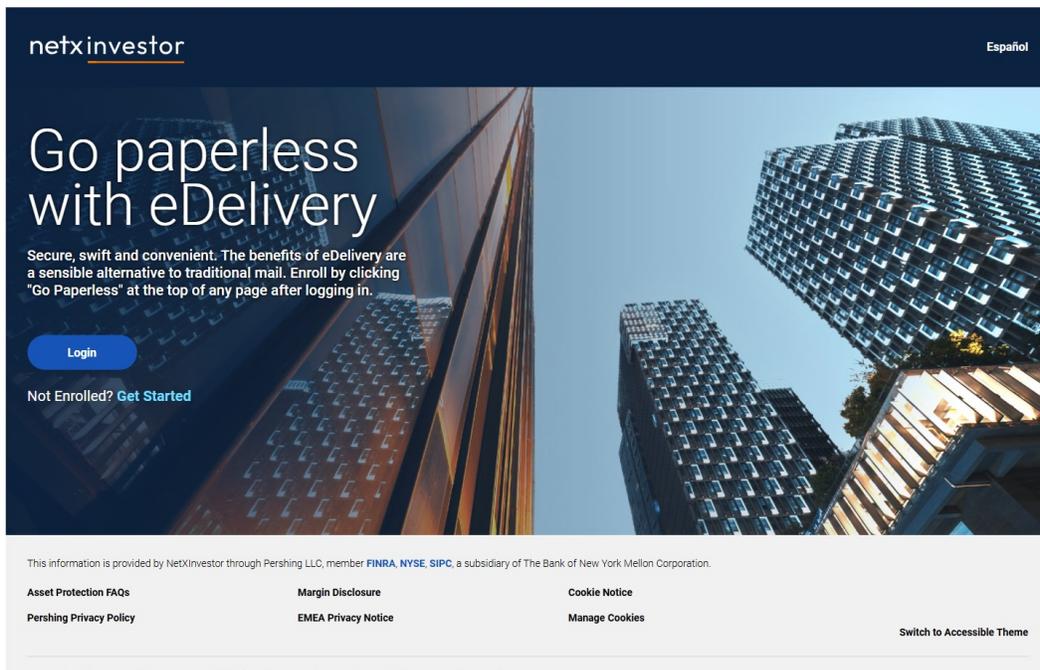
Eligible registration types include but are not limited to:

1. Individual
2. Joint
3. Traditional IRA
4. Roth IRA
5. Rollover IRA

Ineligible Accounts for Self-registration:

- Accounts that are not under a natural person or Social Security number (SSN)
- Accounts under a TIN

1. Go to www.netxinvestor.com.
2. Select the **Get Started** hyperlink.

Successful online registration will provide immediate access to your accounts. At this time, accounts without a Social Security number are not eligible for online registration. In addition, if your Social Security number is not recognized as being associated with the account number you enter into the system, your online registration will be unsuccessful.

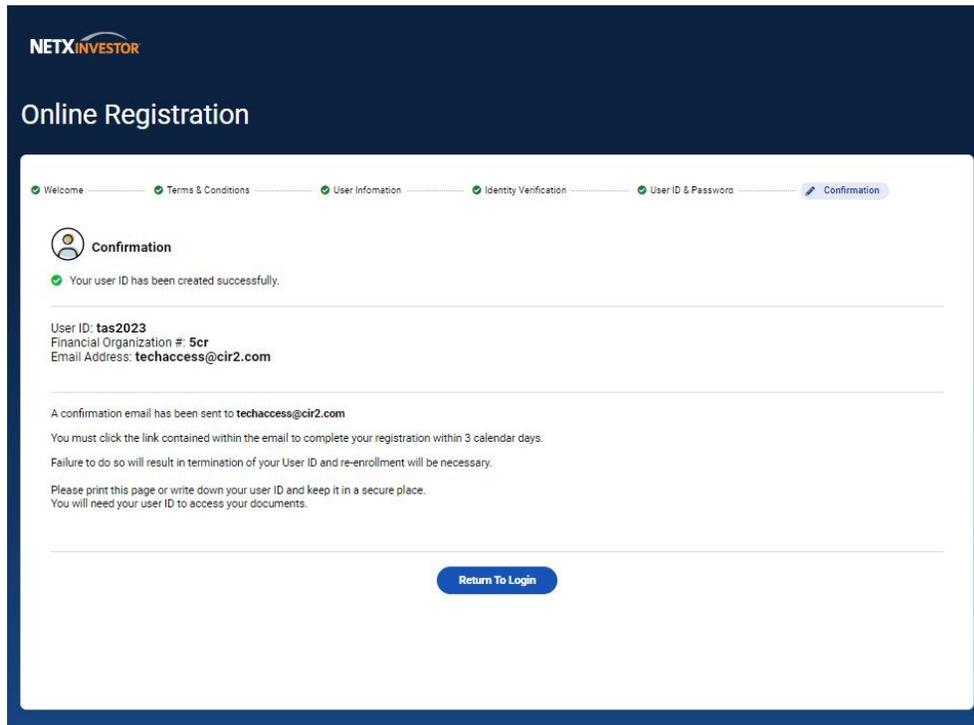

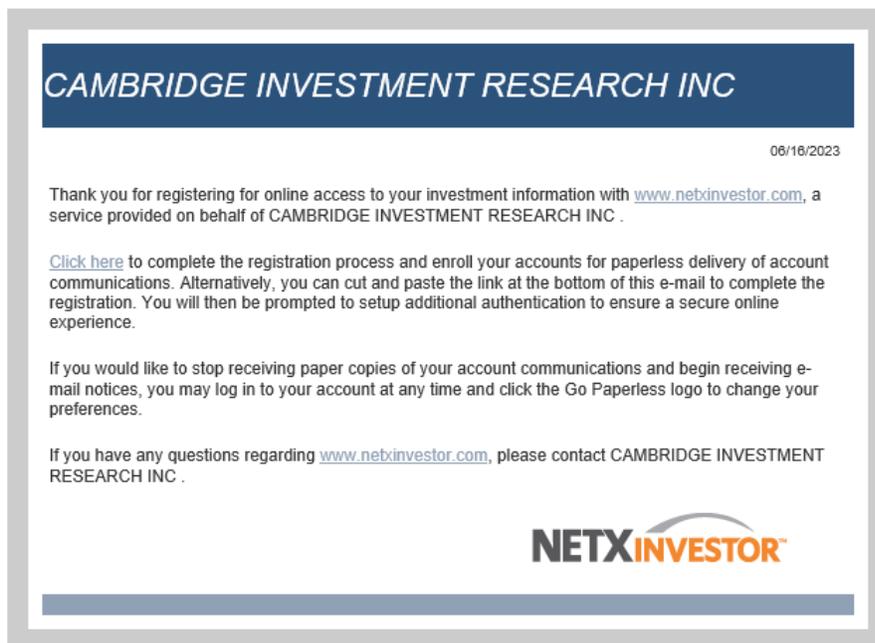
To create an acceptable password your password must:

1. Not contain same as the user ID
2. Contain a minimum of 8 and maximum of 32 characters
3. Contain at least one alpha and one numeric character
4. Not contain linked account(s) name
5. Contain at least one uppercase and one lowercase letter

8. Lastly, on the Confirmation tab, the User ID and email address you provided will display. An email has now been sent to you.

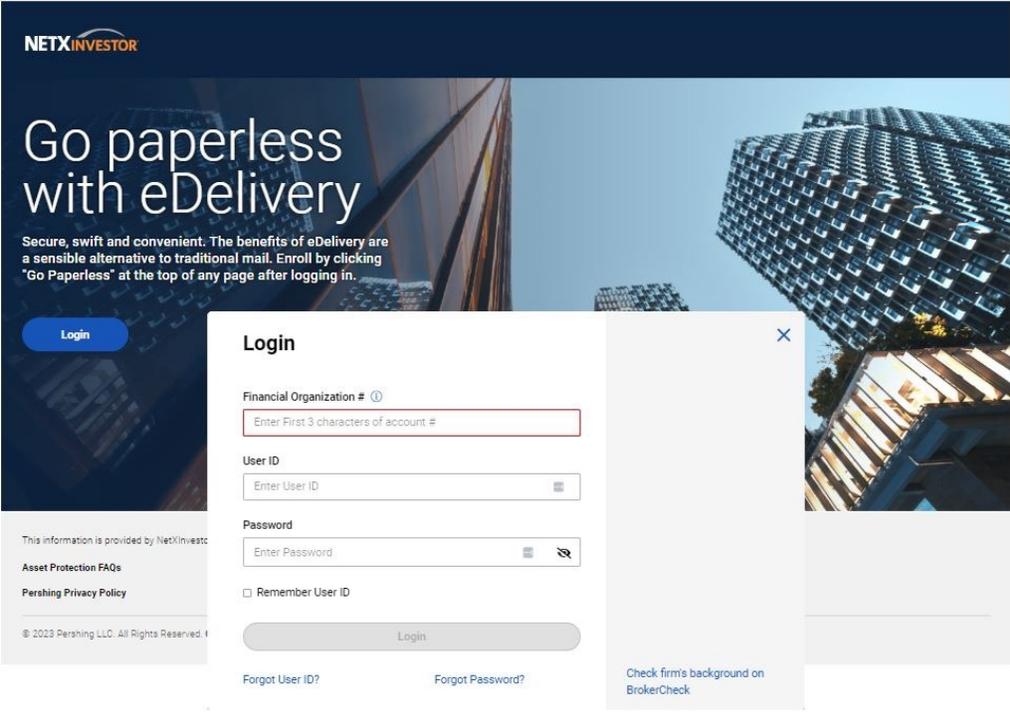


9. Once you receive the email like the example below, select **Click Here**. You will be taken to the login screen for NetXInvestor.

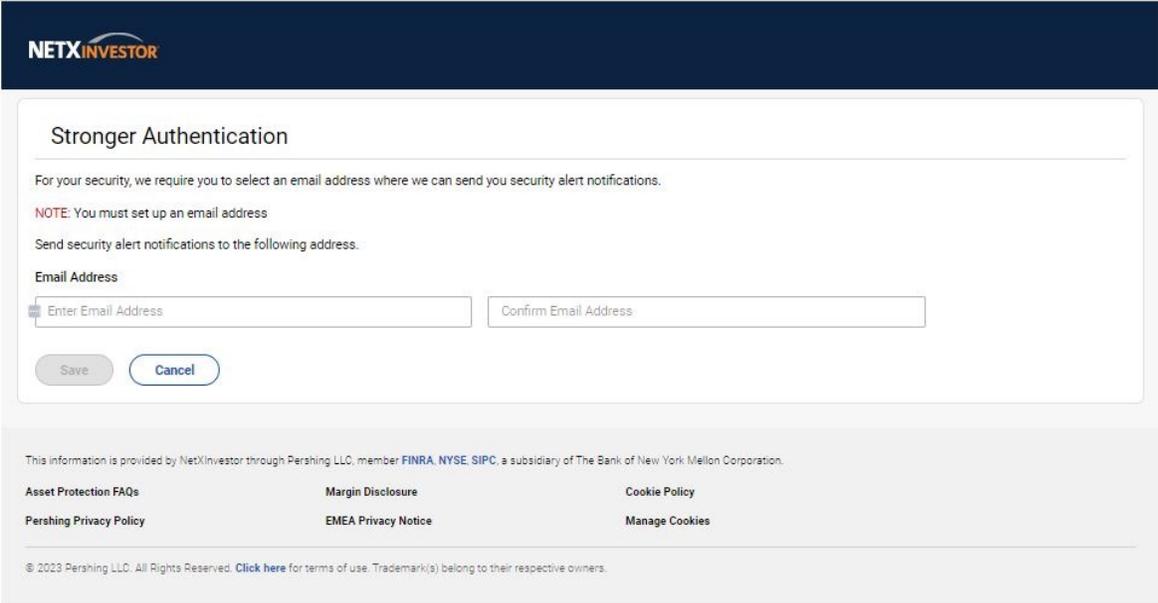


10. To finish the registration process, select **Login**.

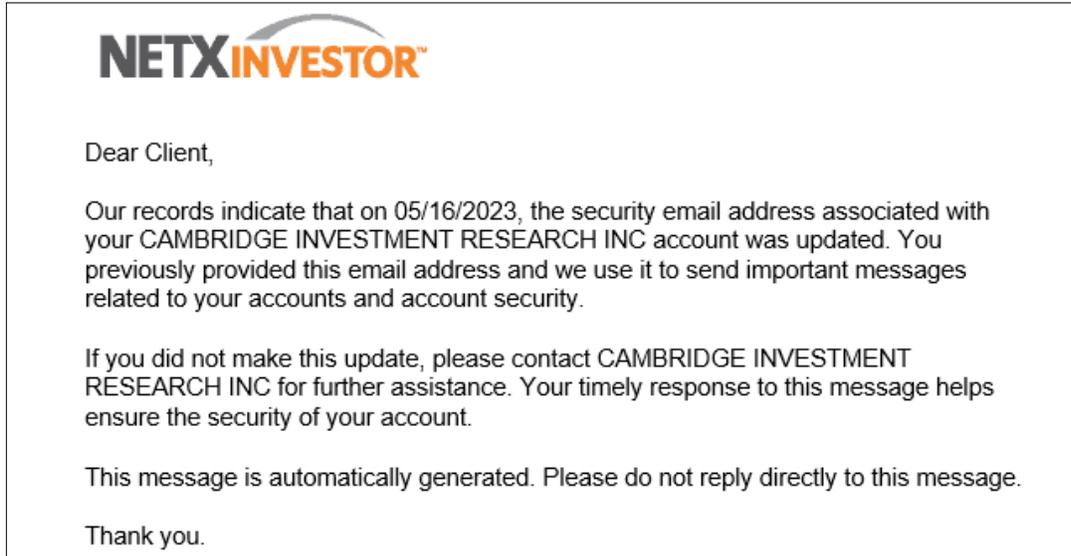
11. Under Financial Organization #, enter **5CR**, followed by your user ID and password, select **Login**.



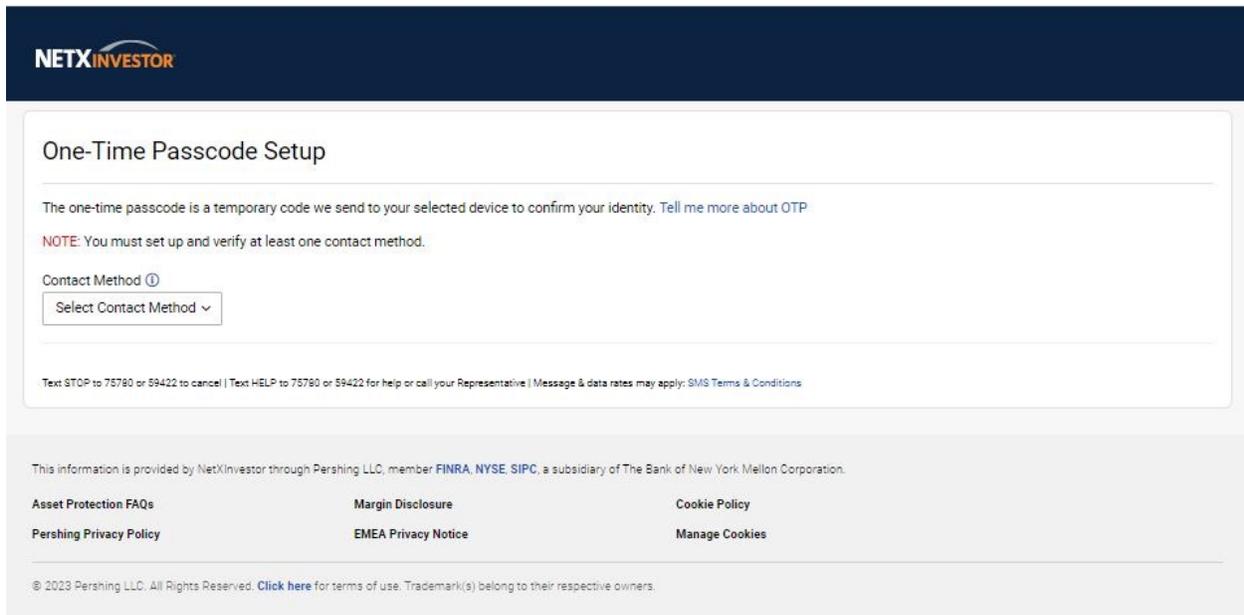
12. On the next screen, Stronger Authentication, the investor will enter and re-enter an email address where security alert notifications will be received.



Once entered, the investor will receive an email like the below.



13. Next is the One-Time Passcode Setup window, this will be used as two-factor authentication for your NetXInvestor login.



- Under Contact Method, choose from SMS/Text, Email, or Voice Call to receive a one-time passcode. Enter the phone number and device nickname (device nickname is required). Select **Verify**.

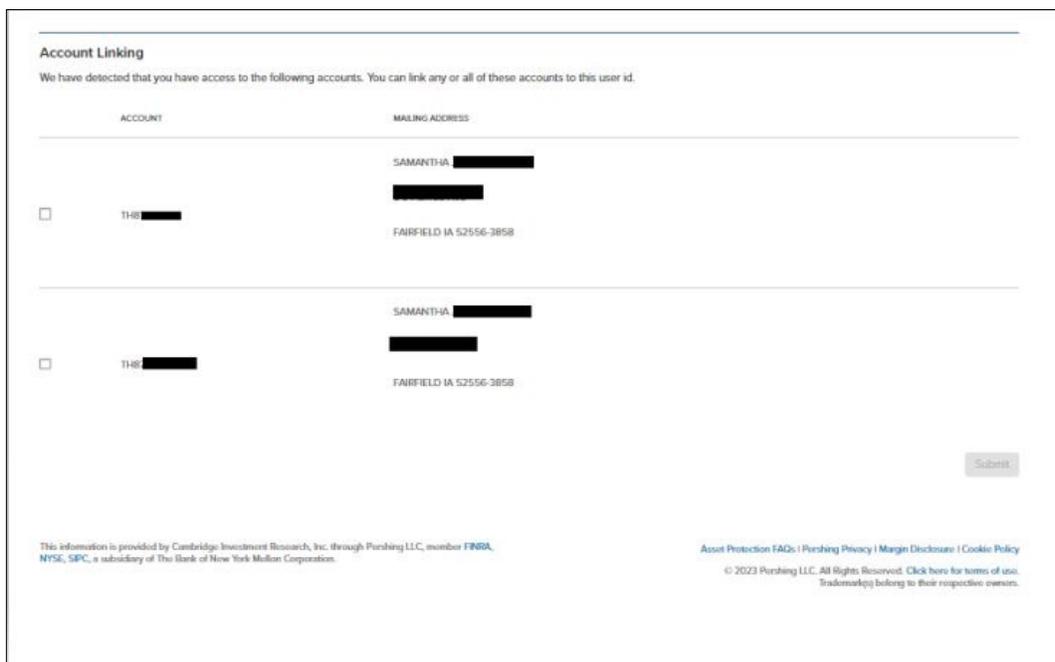
